

**ALTINBAS UNIVERSITY  
LEGISLATION COMMITTEE DIRECTIVE**

**PART ONE  
Purpose, Scope, Basis and Definitions**

**Objective**

**ARTICLE 1** - (1) The purpose of this Directive is to determine the establishment and working principles of the legislation commission operating within Altınbaş University.

**Scope**

**ARTICLE 2** - (1) This Directive covers the duties and working principles of Altınbaş University Legislation Commission.

**Basis**

**ARTICLE 3** - (1) This Directive has been prepared based on Article 14/b of the Higher Education Law No. 2547.

**Definitions**

**ARTICLE 4** - (1) In this Directive:

- a) University Altınbaş University,
- b) Rector: The Rector of Altınbaş University,
- c) Senate: Altınbaş University Senate,
- d) Commission Altınbaş University Legislation Commission.

**PART TWO  
Formation, Duties and Working Principles of the Commission**

**Commission**

**ARTICLE 5** - (1) The commission consists of a vice-rector (the chair of the commission) and four members designated by the Senate. One of the members is assigned as rapporteur by the chairperson of the commission

(2) The term of office of the members of the Commission is 3 years. A member whose term of office expires may be reappointed in the same manner.

**Duties of the Commission**

**ARTICLE 6** - (1) Duties of the Commission;

a) To propose regulations, directives and other legislation in the areas needed by the Office of the Rector,

**Working principles of the Commission**

**ARTICLE 7** - (1) The commission carries out its work under the chairmanship of the relevant Vice Rector. In meetings where the chairman is absent, the most senior member chairs the commission.

(2) The Commission convenes with the absolute majority of the members upon the request of the chairperson, and decisions are taken by majority vote.

(3) Draft regulations, directives and circulars sent to the commission by the Rectorate or university units, as well as proposals prepared for amendments and corrections to existing regulations, are sent to the members for review by the rapporteur. The commission is called to a meeting on the specified day and time. The commission convenes

discusses the issues on the agenda and makes the necessary arrangements. The proposals accepted by the commission are submitted to the senate for approval.

(4) The secretarial work of the Commission is carried out by the rapporteur.

(5) Depending on the subject matter discussed in the Commission, one or more of the unit managers may be invited to attend the meeting to obtain their opinions if necessary.

### **PART THREE Final Provisions**

#### **Situations Without Provisions**

**ARTICLE 8** - (1) In cases where there is no provision in this Directive, the provisions of the Higher Education Law No. 2547, Altınbaş University regulations and other relevant legislation shall apply.

#### **Enforcement**

**ARTICLE 9** - (1) This Directive enters into force on the date it is adopted by the Senate.

#### **Execution**

**ARTICLE 10** - (1) The provisions of this Directive are executed by the Rector.
